Dear Educator:

Each year, the Federal Bar Association ("FBA") sponsors a national civics essay contest, which is open to middle and high school students. In addition to the national contest, I am pleased to announce that the United States District Court for the Eastern District of Tennessee, in partnership with the Knoxville and Greeneville Chapters of the FBA, is sponsoring a local essay contest.

The Court and the local FBA chapters want to encourage students to participate in the national contest by offering cash awards to high school students who submit entries to both the national and local contests. The local contest is open to public, private, and home high school students from the counties served by the Knoxville and Greeneville court divisions. The essay topic for both the national and local contest is "What Does It Mean to Support and Defend the Constitution?" A detailed prompt is contained in the attached announcement, and additional information for both contests (with hyperlinks) is available on our Court's Outreach and Education webpage: www.tned.uscourts.gov/outreach-and-education.

To enter the local contest, students must write an essay and submit it to both the national and local contests. Essays must be submitted separately to the local and national contests by 11:59 p.m. on March 31, 2021. Prizes for the local contest will be awarded in at least the following amounts:

- 1st place: \$500.00
- 2nd place: \$300.00
- 3rd place: \$150.00

Winners of the local contest will be announced by May 15, 2021. Additionally, winners, along with their parents and teachers, will be invited to a celebration reception with federal judges and attorneys from the local chapters of the FBA. Winners will also have their entries published on the federal court's civics website and be recognized at an upcoming meeting of the Knoxville and Greeneville FBA chapters.

#### Federal Court Civics Essay Contest

The United States District Court for the Eastern District of Tennessee, Knoxville and Greeneville Divisions, in partnership with the Knoxville and Greeneville Chapters of the Federal Bar Association, is sponsoring a local civics essay contest. Each year, the national Federal Bar Association (FBA) sponsors a civics essay contest, which is open to middle and high school students nationwide and, for 2021, provides six cash awards totaling \$4,500. The Knoxville and Greeneville divisions of the federal court and local chapters of the FBA want to encourage local students to participate in the national contest by offering cash awards for **high school students** who submit entries to both the national and local contests.

The local contest is open to public, private, and home high school students from Anderson, Blount, Campbell, Carter, Claiborne, Cocke, Grainger, Greene, Hamblen, Hancock, Hawkins, Jefferson, Johnson, Knox, Loudon, Monroe, Morgan, Roane, Scott, Sevier, Sullivan, Unicoi, Union, and Washington Counties. The topic for the national and local essay contests is the same, as detailed below: *"What Does It Mean to Support and Defend the Constitution?"* 

To enter the local contest, students must write an essay for submission to both the national and local contests, following the criteria and rules for the national contest (described in detail below). Essay entries for the local contest must be submitted in either PDF, DOC, or DOCX format and must be accompanied by the attached submission form for receipt by 11:59 p.m. on March 31, 2021, at the local contest email address, <u>KXGVcivicsessay@gmail.com</u>. (Please note that the national contest deadline is also March 31, 2021; however, entries for the local and national contests must be submitted separately.)

Prizes for the local contest will be awarded in at least the following amounts:

First Place: \$500 Second Place: \$300 Third Place: \$150

Winners of the local contest will be announced by May 15, 2021, and the winners, along with their parents and teachers, will be invited to a celebration event with federal judges and members of the local chapters of the Federal Bar Association. The winning authors and entries will also be announced in a court press release and recognized on the federal court's civics website and at meetings of the Knoxville and Greeneville chapters of the FBA.

## What Does It Mean to Support and Defend the Constitution? \_\_\_\_\_

### 2021 Civics Essay Contest Sponsored by Federal Bar Association

### Have you ever taken an oath or witnessed the administration of an oath?

The United States has a long history of these solemn declarations, starting with the ratification of the U.S. Constitution in 1788, which established the Presidential Oath of Office, perhaps the most well-known oath. The federal government requires <u>oaths prior to officials taking office</u>, also known as swearing-in ceremonies.

This year, the Federal Bar Association acknowledges the contributions of those who swear an allegiance to uphold the Constitution of the United States of America by asking students to consider what it means to support and defend this document which establishes the basic principles of the American Government.

#### FAST FACTS about Oaths

- The Constitution only specifies an oath of <u>office for the President</u>, but Article VI requires one of other officials.
- The Presidential oath is the only sentence contained in quotation marks in the Constitution.
- A state legislator once introduced <u>a bill</u> to have high school students take an oath as a condition of graduating.
- <u>Benedict Arnold</u> learned the consequences of failing to follow his oath: He got caught conspiring to surrender West Point to the British in 1780, and his name was erased from the U.S. register of officers. He was labeled a traitor and suffered a tarnished reputation.
- <u>Naturalized U.S. citizens</u> swear an oath to support and defend the Constitution, "so help me God," as the final step to citizenship, but an alternate, secular version is available if requested.

What does it mean to take an oath to support and defend the Constitution and why is it important? Why is the oath different for different groups? Why and how are oaths carefully and precisely worded? Do you agree that oaths should be required under certain circumstances? What do you think about being required to take an oath to graduate from high school? Can an oath be ended? How?

### Timeline of Oath History

June 21, 1788 – U.S. Constitution Ratified. Article II, Section I sets forth the Presidential Oath of Office.

**March 26, 1790** – Naturalization Act of 1790 requires applicants for citizenship to swear an oath to support the Constitution.


**May 13, 1884** – Congress changes oath for federal employees, eliminating the post-Civil War "Ironclad Test Oath" that had required individuals to swear that they had "never previously engaged in criminal or disloyal conduct."

**June 29, 1906** – Naturalization Act of 1906 requires naturalized citizens to swear an oath to "support and defend the Constitution and laws of the United States against all enemies, foreign and domestic."

**October 5, 1962** – Public Law 87-751 provides that individuals enlisted into the Armed Forces of the United States shall take an oath to support and defend the Constitution of the United States.

**September 6, 1966** – Public Law 89-554 establishes oath of office for all federal employees other than the President.

January 23, 2013 – Arizona legislator introduced HB 2467 proposing an oath to support and defend the Constitution for all high school graduates.

The Federal Bar Association invites middle and high school students to consider the question: "What does it mean to support and defend the Constitution?" Students should address the role of oaths in government and the relation of oaths to the U.S. Constitution and explore topics such as: why oaths are required for certain individuals; how oaths have evolved over time; and what does supporting and defending the Constitution mean today? Essays should cite relevant statutes and/or cases as well as applicable historical events.

# 2021 FBA Civics Essay Contest Rules

Who May Enter	The contest is open to middle and high school students enrolled in public, private, parochial and charter schools and home-schooled students of equivalent grade status in the United States and its Territories. Middle school students are defined as those in grades 6-8. High school students are those in grades 9-12.
Essay Length and Format	<ul> <li>The maximum essay length in the Middle School Division is 500 words, and the maximum length is 1,000 words for high school entries. While not required, proper use of endnote citations and bibliographies will be credited during judging but are not be included in the word count. Essays must be submitted as a Microsoft Word document (preferred) or PDF file and follow these formatting guidelines:</li> <li>Use 12 pt. Cambria or Times New Roman font, double-spaced text, with one-inch margins</li> <li>DO NOT include a title page, page headers or footers, or page numbers</li> <li>Include your name on the first page only</li> <li>Place all in-text, numbered citations at the end of your essay as endnotes, followed by a bibliography (if included)</li> <li>Name your file as follows: Firstname Lastname.ext (example: John Smith.doc; John Smith.pdf)</li> </ul>
Entry Submission and Deadline	Essays must be submitted with a completed entry form, available at <u>https://www.surveymonkey.com/r/Essay21</u> . The online entry form provides instructions for uploading documents. Entries accepted through 11:59 p.m. Pacific Time on March 31, 2021. Winners will be notified no later than June 1, 2021.
Judging	<ul> <li>Essays will be evaluated based on the following criteria:</li> <li>Understanding of constitutional principles – 40 points</li> <li>Clarity and effectiveness in expressing the theme – 30 points</li> <li>Grammar, spelling and composition – 25 points</li> <li>Use of footnotes, bibliographies – 5 points</li> </ul>
Prizes	<i>Middle School Division:</i> First place, \$750; Second place, \$500; Third place, \$250 <i>High School Division:</i> First place: \$1,500; Second place: \$1,000; Third place, \$500
Publication Release	As a condition of entry acceptance, all publishing rights are retained by the Federal Bar Association and the association reserves the right to copyright material in its name and to reprint it in any FBA publication/media as it sees fit.
Copyright	Adherence to all U.S. copyright laws and fair use practices is required. Visit <u>www.fedbar.org/about-us/outreach/civics-essay-contest/</u> for more information and resources.
Disqualification	Reasons for disqualification include (but are not limited to): incomplete or improperly formatted entries, off-topic essays, providing false information, committing plagiarism, not meeting the submission deadline, and not providing a release form if requested.
